Welcome and Call to Order

Meeting called to order at 12:01 PM by Interim President Dunlap. The meeting took place via Teams.

Roll Call and Establishment of Quorum

Roll call was taken and quorum was established.

The meeting minutes from April 21, 2026 and May 15, 2026 were unanimously approved and will be uploaded to our website.

Officer Reports

1. Interim President's Report: Patty Dunlap shared that she is excited about the new year and new BOD. She thanked the outgoing BOD members. The 602 Day tabling was successful and the ERG leaders met with a rep from Silent Witness to provide some prof. development training in the new FY.
2. Vice President's Report: Vacant
3. Treasurer's Report: Treasurer Greenberg reported that our bank account has \$10,774.13 including \$70 from new paid members. The alliance currently has 35 members for FY26/27 (3 paid and 32 in process for EDF reimbursement). All of the Treasurer folders have been established for the new fiscal year and are prepared for the new Treasurer. MAL Lacheta has been inquiring about funds for this year's Pride Parade. The alliance received payments from NAN, PHN, WIL, and COPEFC (total of \$200) for the NEO swag project led by Secretary Yount.

Committee Reports

1. Professional Development: Chair Christensen shared the summer film series -- Are You Proud? (June), Time Passages (July), and Forbidden (August). He asked that the board attends more of the film discussions. A Coming Out Day panel is being identified.
2. Networking & Community Service: Pride social at a local bar is being planned by MAL Lacheta.
3. Membership: Chair Greenberg has updated the membership application form for FY26/27 -- including an option to submit dues with Zelle.
4. Communication: Chair Lawler (absent) had no new updates.
5. Pride: The Board is actively recruiting a new Chair

New Business

1. End of Year Memo/Report - Secretary Yount prepared an end of year report and sent it to Ex. Sponsor Steventon.
2. 501(c)(3) establishment -- Treasurer Greenberg needs to finalize and submit the Articles of Incorporation, pending the current officers respond with any edits.
3. NEO Pens -- Secretary Yount has reached out to the ERG leaders to see what swag item should be purchased to give out at NEO meetings. A purchase will be made in late June/early July.
4. Transition of Roles and Responsibilities-- Secretary Yount and Treasurer Greenberg have both set up ways to transfer knowledge to the new BOD members.
5. Training Update - MAL Lacheta discussed that the video recording for the PHXYou training will take place at PHX TV Studio. The Mayor pre-recorded a video that will be featured in the training and members from CMO have been contacted to participate in the recording.
